Stolen car of wounded student recovered

Authorities Tuesday night recovered the stolen car of a Southern University student who was wounded by gunfire on campus Tuesday, but the man driving the stolen car escaped from officers, Southern Police Chief Harrison Baptiste said. "Stephen Uwaezuoke, 29, a graduate student from Nigeria, was shot three

times as he approached his car about 12:45 a.m. Tuesday, spokesman Clayton Lewis said.

Uwaezuoke was listed in stable condition at Our Lady of the Lake Regional Medical Center with wounds to an arm, leg and his abdomen, hospital spokesman said

Uwaezuoke gave investigators a brief statement before being rushed to the hospital, Lewis said. The victim told investigators a man approached him while he was working on a project in T.T. Allain Hall and requested his car keys, Lewis said. The victim said he did not know the man, kept his keys and the man left.

A short time later, the victim went out to his car and the same man approached him and demanded the keys to the victim's 1965 Volvo, Lewis said. Uwaezuoke refused and was shot in the left arm and left leg, he said. During surgery, fragments also were removed from a gunshot wound in the The man who fired the shots also stole the victim's car, he said.

About 9:30 p.m., city police officers spotted the victim's car on Longfellow Street and stopped the vehicle, Baptiste said. However, the driver of the car jumped out and escaped. The car will be taken to the State Police Crime Lab for examination,

N.C. fugitive booked in kidnapping

MANY - A North Carolina fugitive accused of kidnapping an elderly man from his Sabine Parish home was captured Tuesday during a parishwide manhunt, police said.

Willis M. Blackmon, 27, was booked with aggravated kidnapping Blackmon is accused of kidnapping former Sabine Parish High School Principal T.A. Maxie from his home in Many on Monday, robbing him of \$173 and forcing him to drive to Zwolle.

Blackmon fled on foot when Maxie stopped at a Zwolle gas station. The fugitive was captured in a wooded area in Zwolle, said detective James McComic. Maxie was not injured, McComic said, "I didn't have time to be afraid," Maxie, 74, said shortly after Blackmon

was captured. "I was just thinking of how to get away. I guess I was scared inside, though. I don't know what he was planning to do. McComic said Biackmon is wanted by police in Southern Pines, N.C., on charges including armed robbery and assault with a deadly weapon.

Subpoena snafu results in trial delay

CLINTON — Prosecutors have postponed the trial of an Ethel teen-ager on misdemeanor charges stemming from a July 30 traffic accident that killed four people, District Attorney Hal Ware said Tuesday. Clyde Whitfield, 17, was scheduled to face trial in 20th Judicial District Court Tuesday on six counts of vehicular injury, reckless operation and

driving without a license, but subpoenas for three state troopers needed as state witnesses had not been served. Ware said The district attorney said the East Baton Rouge deputies apparently delivered the subpoenas to Louisiana State Police Troop A, but the troopers

did not receive them. He said he did not know how the mix-up occurred. "We tried until 7:30 last night (Monday) to get in touch with them, but we simply couldn't catch up with everybody. Ware said the misdemeanor charges will be considered along with four

felony counts of vehicular homicide in a Jan. 16 jury trial. State police said Whitfield was the driver of a 1988 Camaro that collided with three cars on La. 10 east of Jackson, killing Whitfield's cousins, Robert Whitfield, 19, and Donald Ray Whitfield, 23, both of Ethel, Terry Baggett, 30, of Baker, and Charlene Schaefer, 44, also of Baker.

Whitfield has remained in the East Feliciana Parish Prison since he was released from a doctor's care in mid-August. He initially was charged with driving while intoxicated — pending blood-alcohol analysis — but Ware said that charge later was dropped.

The blood sample analyzed by the Louisiana State Police Crime Lab was taken several hours after the four-car collision and the results were inconclusive. Ware said. However, a blood sample was taken earlier by a Lane Memorial Hospital physician, the district attorney said, and prosecutors will use expert witnesses in an attempt to prove Whitfield was under the influence of alcohol at the time of the crash.
